HOW WE PROVIDE GOOD COMMUNICATION TO HEALTH CARE PROVIDERS ON INSURANCE ISSUES

On June 14th, 2007, we will be putting on an all day conference for health care providers, which we hope will provide a mountain of information to aide them in the care of their patients.

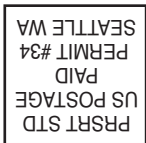

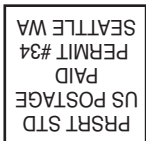
